## 16th USPE European Police Championships Shooting

### 17th - 22nd July 2017 in Kazan/Russia

### **Invitation to Enter**

The Russian Public and State Police Sports Association "Dynamo" was entrusted by the Union Sportive des Polices d'Europe (USPE) with the organization of the 16th USPE European Police Championships Shooting from 17th – 22nd July 2017 in Kazan/Russia.

The following invitation to enter is issued for the USPE EPC Shooting 2017.

The organiser will provide the transportation from Airport Kazan (KZN) or Train station to the hotel according the travelling details of all the delegations.

Delegations which need a VISA are requested to contact the host in time.

When submitting documents to the Russian Embassy in the corresponding country one should indicate the purpose of the visit – USPE Championship.

### Therefore the organiser needs of each delegation:

- the full names of the participants
- date of birth
- the number of the passport.

Shuttles during the EPC:

The organiser will provide all shuttles during the EPC. The schedules will be given to delegations on arrival day.

### 6. Safety Requirements

The organizer has to ensure that a medical first aid will be present at every event.

The organizer also has to make sure to meet the safety requirements.

The organizer is responsible for a safety and security analysis of the risks during the EPC to determine the necessary precautions and measures.

#### 7. <u>Insurance</u>

Everyone involved in the USPE EPC is responsible for his/her own insurance cover.



The participating Member Countries are responsible for and undertake to conclude all necessary and adequate insurance cover (e.g. accident and health insurance) for their whole delegation members at their own expense for the whole duration of the USPE EPC.

All insurances must cover the full period of the USPE EPC.

Claims for damages against the USPE are expressly excluded

### 8. Competition rules

The provisions of the USPE Competition Rules, item 4.13, shall apply.

The competitions will include the following events:

#### Men:

- 1. 10m Air Pistol Men, 60 shots.
- 2. 25m Center Fire Pistol Men, 30 + 30 shots.
- 3. 25m Rapid Fire Pistol Men, 60 shots.
- 4. 50m Pistol Men, 60 shots.
- 5. 10m Air Rifle Men, 60 shots standing.
- 6. 50m Rifle Prone Men, 60 shots prone.
- 7. 50m Rifle 3 Positions Men, 3 x 40 shots kneeling, prone, standing.

#### Women:

- 1. 10m Air Pistol Women, 40 shots.
- 2. 25m Pistol Women, 30 + 30 shots.
- 3. 10m Air Rifle Women, 40 shots standing.
- 4. 50m Rifle Prone Women, 60 shots prone.
- 5. 50m Rifle 3 Positions Women,  $3 \times 20$  shots kneeling, prone, standing.



Each member union may enter up to two sportsmen/-women in each discipline.

Each member union may send up to 22 sportsmen/-women as well as up to four attendants.

However, the number of attendants must not exceed the number of sportsmen/-women.

### 10. Juries

### 10.1. Jury of appeal

The provisions of the USPE Rules and Regulations, Article R 19, shall apply. The Jury of Appeal for the USPE EPC Shooting 2017 is comprised of:

All appeals have to be made in writing in one of the three official languages of the USPE by the delegate or one of the attendants of the member union in question within less than an hour after the respective competition is over unless the respective international sport rules specify different.

The delegate or one of the attendants of the member union has to enclose an appeal fee with the appeal in order for the appeal to be valid.



The deposited sum will be refunded to its owner if the appeal proves to be justified.

If the appeal is rejected the sum deposited is retained by the USPE.

The appeal fee will be a total of 100.00 EUR, paid in cash.

### 10.2. Jury

The participating nations are requested to designate judges for ensuring the composition of the following juries: classification, pistol, and rifle as well as weapons and sports garments control. Assignment to the individual juries will be determined by the technical delegate and the Secretary General.

### 11. Eligibility to start

The provisions of the USPE Statutes, the USPE Rules and Regulations, the USPE Competition Rules as well as the USPE Anti-Doping Regulations shall apply.

Doping tests will be conducted during the Championship, with the current WADA list of prohibited substances being applicable. (www.wada-ama.org).

### **USPE Statutes Article 23: The Competitors**

- (1) Participation in championships is restricted to athletes, who:
  - 1. meet the starting requirements of their international union,
  - belong to a national sports organisation that is a member of the USPE,
  - 3. are police officers or
  - 4. are police students at a public police academy,
  - 5. have reached the age of 18 at the time of the championships (including preliminary rounds),
  - 6. have signed the Anti-Doping Declaration,
  - 7. and submit the USPE Declaration of Participation signed by the respective President/Secretary General to the competent



member of the Technical Commission.

### **USPE Rules and Regulations Article R 12/2: Competitors**

- (1) In order to be able to take part in an European championship organised by the USPE, the members of the member unions have to fulfil the following conditions:
  - 1. They have to satisfy the provisions set out in Article 23 of the Statutes.
  - 2. They have to be police officers or students at a public police academy.

The police are a set of all bodies and institutions in charge of maintenance of public law and order (administrative police and crime investigation departments).

(2) Military police, members of the military, members of fire brigades and civil servants that do not belong to the police are excluded from European police championships.

### **USPE Competition Rules paragraph 1.6:**

Competitors suspended from sports contests by the respective sports association due to having violated the relevant doping regulations are not eligible to enter.

### **USPE Competition Rules paragraph 1.7:**

All teams shall wear uniform sportswear displaying the emblems of their individual member union.

### 12. Accreditation/Verification of eligibility to enter

For verification of a person's eligibility, the presentation of the police ID and passport or national ID-card (including a photo) must be presented to the Technical Delegate of the USPE. In case these documents are not presented, permission to start could be refused.



According to the USPE Statutes, all participating countries must present the USPE Declaration of Participation for each athlete who will participate, signed by the respective President or Secretary General.

Without these Declaration the participation at the USPE EPC is not possible!

The competent member of the USPE Technical Commission, Mr. Jörg Hirschberger, will affect the verification.

### 13. Anti Doping

Doping tests (urine and/or blood) will be conducted during the championships, with the current WADA list of prohibited substances being applicable. (www.wada-ama.org).

Every Competitor must sign the USPE Anti-Doping-Declaration and hand it over to the USPE Technical Delegate at the accreditation.

Without these Declaration the participation at the USPE EPC is not possible!

If you take prohibited substances or use prohibited methods mentioned in the WADA Prohibited list to treat an illness or condition, you need a Therapeutic Use Excemption (TUE) to participate.

### 14. Expenses/fees

### 14.1. Travelling expenses

Each member union will defray its own travelling expenses.

### 14.2. Board and lodging

#### Delegate:

The organizer will pay the expenses incurred by the delegate (USPE Rules and Regulations Article R 11) of the respective member union.

#### 14.3. Registration fee

USPE Rules and Regulations Article R 14/2:

Prior to a championship, each participating nation has to pay a registration fee to the General Treasurer of the USPE.

This fee has to be paid before the opening of the championships.

### 15. <u>Notes</u>

### 15.1. Import regulations

1. The competitors have to come to Russia for the competition with their weapons, ammunition and equipment, all of this transported according to the current transportation standards stipulated by the respective airline companies.

The delegations must be able to produce the following documents:

- An invitation to participate in the European Police Shooting Championship which indicates the date and the venue of the competition.
- A list of the names of their respective competitors indicating weapons and ammunition (brand and serial number of weapon, calibre every competitor must own a European firearms pass stating the following information: brand of weapon, first and last name of the holder of the weapon, photo, list of the various weapons transported etc.)
- 2. Upon arrival at the competition venue, all weapons (in their containers) and all ammunition will be stored by the competitors of every delegation in the provided lockers which are located in the surrounding wall of the shooting range. These weapons and ammunitions will be listed and guarded by the Russian police.
- 3. These weapons and ammunitions will be removed from the lockers by their respective holder prior to every competition in which he/she participates. After this competition, the weapon will be returned to the locker after being checked by a person responsible for this task.
- 4. Weapons and ammunition will not be permitted on any of the premises (accommodation, restaurants, other premises and neighbouring public spaces).
- 5. No delegation member will be permitted to carry weapons or ammunition during non-competition times or while engaging in leisure activities, no matter whether on their person, in a container or a vehicle for transportation purposes.



#### 15.2. Contestants in uniform

One contestant per team has to wear the police uniform of their respective country at the opening ceremony.

All teams shall wear uniform sportswear displaying the emblem of their individual member union during the opening as well closing ceremony.

As to the Final Banquet, you are requested to attend adequately dressed to suit the occasion (no blue Jeans).

The participating teams are responsible for the insurance of their delegation.

### 15.3. Shooting targets

SIUS ASCOR electronic targets will be used for all competitions.
